



VENDOR APPLICATION

Ogden's 2nd annual festival of witches, Witchstock, will be held on Saturday, October 22, 2011. The night will be filled with thousands of witches celebrating a witches night out by taking part in a scavenger hunt and ghost tours, attending a witch's tea party, having their fortunes told and partying in the Historic Union Station, all the while having fun dining, shopping, dancing and more! Proceeds from the event will be donated to the Union Station Foundation.

The party begins at 3:00pm. Vendors will be placed inside Union Station with special "quiet" locations for card readers, fortune tellers,

angel readers, etc. Vendors must remain open for business from 3:00pm until 9:00pm. Fees are \$40 which includes the Ogden City Special Event \$5.00 license. Fees do not include health department permit fees required for food vendors. Vendors will be assigned a location but must provide all supplies necessary to set up a booth. An additional fee of \$10 will be required for all vendors requesting electricity. Booth sizes are 10' x 10'. Two chairs and an 8' table will be provided for each vendor. Set up time will begin at 1:00pm with all vehicles required to be moved to the vendor parking across the street from the station no later than 2:30, one half hour prior to festival opening at 3:00pm. Electricity will not be provided. Vendors are encouraged to utilize solar powered lights and/or battery operated lights.
